Subject: Sanction order for commencement of pre-construction and construction work in the State of Maharashtra State.

- 2. MoTA file no. 18015/22/2019-EMRS dated 28.07.2020 "Notification of state wise allocation of work for construction of EMRS among the empaneled construction agencies."

With reference to above referred orders, NESTS has assigned the construction work of 14 EMRS of the State of Maharashtra to M/s Engineering Projects (India) Limited (M/s EPIL) out of which 07 nos.
